A petition of Robertson Stevens, late sheriff of Dorchester county, setting forth, That by the uncommon severity of the weather he was prevented from making his collection of the affeliment in time, and therefore praying to be relieved from the penalties incurred in consequence thereof, was preferred and read.

Mr. Ringgold brings in and delivers to Mr. Speaker a bill, entitled, An act to prohibit the going at large swine and geese in Queen's-town, in Queen-Anne's county; which was read the first time and ordered to lie on the table.

THE committee appointed to examine and report on the petition of Mary Cox, beg leave to report, That they have examined the facts in the said petition contained, and find them to be justly stated, and are of opinion, that the families of those officers and privates in the militia, who have or may be killed or die of their wounds in the actual service of their country, ought to receive such support as their particular circumstances shall appear to the orphans court to merit, which said court ought to be empowered to give an order, from time to time, on the sheriff of the county, in favour of fuch family, for fuch fums of money as they may think just and necesfary for the support of such family; and where it shall be made appear to the commissioners of the tax, that such estates cannot be taxed without greatly distressing the said families, that in every fuch case the said commissioners ought to have power to exempt such estates from being taxed. All which is submitted to the consideration of the honourable house.
