THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. J. Stevenson has leave of absence until Tuesday next.

Mr. Stricker brings in and delivers to Mr. Speaker a bill, entitled, An act to raise a company of infantry to serve within the state; which was read the first and second time by especial order, passed, and sent to the senate by Mr. Stricker and Mr. Chapline.

Mr. Cramphion has leave of absence. Mr. C. Ridgely has leave of absence until Wednesday morning next.

A remonstrance of Robert Riddle, of Baltimore county, setting forth, that the convention in the year 1776 advanced him £. 1000, to enable him to erect a bleaching mill and works, &c. and that he gave bond to pay the same in money, or brown or white linen, within thirteen months; that neither the convention or council of safety made a demand of the money or linen within the thirteen months, or since; that he made a tender of the money with interest to the commissioners for the settlement of the public accounts, and the treasurer, and demanded his bond, which they refused; and therefore praying that an order may be given for the delivery of his bond upon payment of the money and interest; was presented and read.
