That the governor and council allow to the persons by them appointed for the purposes asoresaid such reward for their trouble or service, to be charged to congress, as they may think ade-

quate thereto.

That the president and speaker inform congress, that a considerable quantity of flour and grain has been produced by this state for the use of the United States, and that this state will take every effectual measure to surnish its quota of the supplies required by the resolve of congress of the 25th of February last, and request congress to appoint proper persons to receive the supplies to be surnished by this state.
