

tobacco, and the time and name of the person lending, and on producing such receipt to the treasurer of the western shore, he shall issue his certificate or certificates in the form prescribed by the act for calling out of circulation, &c. for the amount of the money, tobacco, or specie, expressed in the receipt, bearing an interest of six per cent. from the day of the loan, expressed in the receipt, the owner may pay such certificate or so much thereof as he pleases in discharge of his taxes, or receive the whole, or any sum of paper money or tobacco due on his certificate, from either of the treasurers, out of any paper money or tobacco in their hands by taxes or otherways, and where any certificate shall issue for specie, the same shall be paid in specie within one year after the conclusion of the present war, or three years from the date of the certificate, which shall first happen, and the interest shall be paid annually, if required, by either of the treasurers, in paper money at the exchange or difference of value between specie and paper currency, and the certificates for tobacco shall be discharged in kind in the county where received within three years from the date, with six per cent. interest, and all continental bills of credit which have been or may be borrowed in consequence of the requisition of the governor and the council, if required; be paid with six per cent. interest out of the first monies which shall be brought into the treasury, or discountable in taxes, and that all such monies as may be borrowed after the 20th instant, shall be paid in kind, with the like interest, if required, on or before the first of January next.

9. That it is the opinion of the committee, that the members of the general assembly, as an example and encouragement to others, immediately subscribe such sums of paper money, tobacco, or specie, as their abilities and convenience will permit.

10. That the persons appointed to solicit and receive subscriptions, return from time to time to the governor and council a list of the subscriptions by them taken, and transmit as soon as possible the money, tobacco, or specie, by them received, to the treasurer of their shore, and that the governor and council cause the sum required by congress to be conveyed with all expedition to the continental treasury; that the money, tobacco, and specie, remaining, be applied to comply with such requisitions as may be made by congress or the committee of co-operation.

11. That the persons appointed to receive loans be subject to the direction of the governor and council, who will direct the subscriptions to cease as soon as sufficient sums are furnished to answer the requisitions of congress and their committee.

12. That for the speedy and effectual transportation of provisions and other necessary supplies to the army, the several laws relating to the impressing vessels, waggons, and other carriages, be revived.
