2. That it is the opinion of your committee, that no person is empowered to settle the accounts of the commissioners appointed to seize wheat, sour, &c. for the immediate supply of the army, and that the auditor general should be empowered to settle and adjust all such accounts.

All which is submitted to the consideration of the honourable house.
