THE house met. Present the same members as on yesterday, except Mr. Fitzhugh and Mr. Gibson. The proceedings of yesterday were read.

The resolution respecting the general officers in the hospital department, was sent to the senate by Mr. Bruff and Mr. Smoot.

The bill to continue the acts of assembly therein mentioned, was read the second time and passed.

On motion, Leave given to bring in a bill to prohibit, for a limited time, the exportation of wheat, flour, rye, Indian corn, rice, bread, beef, pork, bacon, live stock, peas, beans, oats, and other victual. ORDERED, That Mr. J. Hall, Mr. Cadwalader, and Mr. Bayly, do prepare and bring in the said bill.

The bill for sinking the quota required by congress of this state of the bills of credit, &c. and the bill to continue the acts of assembly therein mentioned, were sent to the senate by Mr. Earle and Mr. Cramphin.

On motion, Leave given to bring in a bill to revive actions and process in the court of appeals, to enable any one judge to adjourn the said court, and to direct the oath of the judges in case of appeals from the court of chancery. ORDERED, That Mr. Chafe, Mr. M'Mechen, and Mr. Dent, do prepare and bring in the said bill.

Mr. M'Mechen brings in and delivers to Mr. Speaker the said bill; which was read the first time and ordered to lie on the table.

The bill for the appointment of several collectors in each county where necessary, &c. was read the second time and passed. Sent to the senate by Mr. Key and Mr. Driver.

The bill for the relief of Thomas Williams, collector of the assessment in Prince-George's county, was read the second time and passed.

The bill for the relief of those who have and may suffer by the British army, was read the second time and passed. Sent to the senate, with the bill for the relief of Thomas Williams, by Mr. Craufurd and Mr. Ward.

On motion, the question was put, That leave be given to bring in a bill to suspend the collection of the treble tax on nonjurors? Resolved in the affirmative. ORDERED, That Mr. M'Mechen, Mr. Key, Mr. Job, and Mr. J. Hall, do prepare and bring in the said bill.

The house adjourns till 3 o'clock.
