Mr. J. Hall brings in and delivers to Mr. Speaker the following amendments to the bill, entitled, A Supplement to the act to procure recruits to complete the battalions of this state, &c. Amendments proposed. Page 1. Strike out in the title the words "A bill," and insert the words "An act." In the fourth line of the same page, after the word "enacted," insert "by the General Assembly of Maryland." In the 6th line of the same page, strike out the word "march," and insert, "arrive at the place or places of rendezvous." In the 12th line of the fame page, after the word "forthwith," insert, "shall give notice to each person in the class named in his warrant of the sum to be paid, and on non-payment by every such person respectively shall." After the word " and," in same line, insert, " after five days notice set up at the most public place on the premises, if the money be not paid."

After the word "aforesaid," in the 6th line from the bottom of said page, add the following: "And in case the lieutenants of the several counties, or any of them, be not surnished with money for recruiting by the governor and council, from the low state of the treasury, or any other cause, such lieutenant shall have full power and authority to call on the classes not finding a recruit, or undertaking on pain of draught to find one, for an advance of money, to be alaced in the hands of a person or persons by him to be appointed to recruit for the deficient classes in his county, and each person shall advance a sum not exceeding one half of the whole sum paya-
