Your committee are of opinion, that as the aforesaid Elias Ransburgh acted under the confidence of the act of assembly, the prayer of his petition should be granted, and that he should have a certificate given him for the faid fum by the treasurer of this state, bearing date with the receipt given by the aforesaid Robert Wood, and that the said Robert Wood should be ordered to attend the bar of the house, to answer for his shameful abuse of the public trust, in not paying the money into the continental treasury.

It appearing to the general assembly, that Mr. Robert Wood, a committee-man for Frederick county, under the act of assembly, entitled, An act for the more effectual preventing forestilling and engroffing, and for other purposes therein mentioned, passed at a session of assembly, held on the twenty-fecond day of July, seventeen hundred and seventy-nine, had received from a certain Elias Ransburgh, of Frederick county, on the 24th day of September 1779, the sum of three thousand pounds current money, on loan to the continent, and had not paid the same into the continental treasury, or obtained a certificate for the aforesaid Elias Ransburgh; therefore

RESOLVED, That the treasurer of the western shore issue a certificate to Elias Ransburgh, of Frederick county, for the sum of three thousand pounds current money, bearing date the 24th

day of September 1779.
