On motion, Leave given to bring in a bill for the building a state gaol. ORDERED, That Mr. D shiell, Mr. Norris, Mr. E. Johnson, Mr. M'Mechen, and Mr. Alexander, do prepare and bring in the faid bill.

The house adjourns till to-morrow morning half after 9 o'clock.

HE house met. Present the same members as on yesterday. Mr. Deye appeared in the

house. The proceedings of yesterday were read. A petition from the trustees of the poor in Frederick county, setting forth, that they received a copy of an act passed this session, in consequence of a petition by them preferred, which they conceive is not agreeable to the prayer thereof, and praying the general affembly to take such measures therein as they may think proper, was preferred and read.

ORDERED, That the letter of John Hanson, Etq; of the 9th of November, be referred to Mr. Clagett, Mr. Hanson, and Mr. Bayly, who are appointed a committee to consider and re-

port on the same.

A memorial from Isaac Perkins, of Kent county, praying the general affembly to direct the auditor-general to give him credit for public flour confumed by fire in his mill, and also to settle his account, making a reasonable allowance for depreciation, was preferred and read, and referred to Mr. W. Stevenson, Mr. Wilmer, and Mr. Clagett, to consider and report thereon.

The engrossed bill No. 27, was read and assented to, and sent to the senate, with the paper

bill thereof, by Mr. Quynn and Mr. Oneale.

Whereas it is represented to this general affembly, That George Mann, of Kent county, John Stump, of Harford or Cæcil county, who was, or pretended to have been, a prisoner in New-York, and George Jackson, of Queen-Anne's county, are disaffected and dangerous perions, and there is good reason to believe that they have purchased up considerable quantities of grain for the use of the enemy, and that their going at large is dangerous to the state,

RESOLVED UNANIMOUSLY, That the governor and the council be authorifed and requested to issue their warrant to the lieutenant of the said counties, or such other person as they shall think proper, immediately to arrest the said dangerous persons, and to take into his possession all the books and papers belonging to them, and to fend them under guard to the governor and the council; and the said lieutenants, or other persons appointed, are empowered to take such part of the militia of their county as they may think proper for the fecuring the faid perforts and their papers; and if any person shall resist the said lieutenants, they are also empowered to seize and fend them to the governor and the council, who are authorised and requested to examine the persons and papers so seized, and to commit, bail or discharge them respectively, in their discretion; and if it shall be discovered, that either of the persons aforeiaid has purchased any grain to export contrary to law, to order the same to be seized.
