Charles Carroll, of Carrollton, Esq; from the senate, delivers to Mr. Speaker the bill to seize, confiscate, and appropriate all British property within this state, and the following message:

By THE SENATE, JANUARY 31, 1781.

GENTLEMEN,

WE agree to strike out of the confiscation bill the parts proposed to be struck out in your message by Messieurs Sulivane and Chapline, and to substitute in their stead the clauses sent with the message, and request that the bill may be amended accordingly, and the exception of debts inserted. We also agree to refer the consideration of the indemnification of sufferers to a future session, when we hope the present subjects of dispute may be settled to general satisfaction.
