aforesaid sum of £. 55,000 0 0, that then they should be at liberty to parcel out and sell the same in such manner as may appear to them most advantageous to the state.

All which is submitted to the consideration of the honourable house.

THE committee, to whom was referred the petition of Susannah Fritchie, Elizabeth Pleghers and Eleanor Shuman, widows of Casper Fritchie, Yost Plegher, and Peter Shuman, who were lately executed at Frederick-town, in Frederick county, for high treason, on behalf of themselves and children, beg leave to report, That by the certificate of Upton Sheredine, William Murdock Beall, and Philip Thomas, Esquires, it appears, that the widows and children aforefaid will be in a helpless and distressed situation, by the confiscation and sale of the property they are now in possession of; which your committee, upon enquiry, are informed, that Casper Fritchie's property consisted only of a house and lot in Frederick-town, some houshold furniture, skinners tools, and a small quantity of skins, and that he left three small children; that Peter Shuman has left a large family of small children, that his estate consists only of a very small quantity of land in Frederick county, a stock of creatures, and some houshold surniture, &c. that Yost Plegher left three small children, that his estate consisted only of some houshold furniture, joiners tools, and a cow. By the above state of facts it appears, that the estates aforesaid are barely sufficient to support the widows and children aforesaid; the committee are therefore of opinion, that, on the principles of humanity, the estates ought to be released. All which is fubmitted to the consideration of the honourable house.

BY THE SENATE, NOVEMBER 27, 1781.

We conceive, that very injurious consequences to the public credit will attend this measure. It is our opinion, that the sale ought to be made as soon as possible, in the manner suggested by the commissioners, which will be most advantageous to the state, and will at the same time preserve the public saith, which we apprehend may be endangered by the delay. We are not informed on the reasons which induced you to postpone the sale indefinitely, we therefore wish to confer with you on this subject, that some mode for managing the business, in a manner satisfactory to both houses, may be adopted, unless you should concur with us in opinion, that it will redound most to the benefit of the public to sell the property in question on the terms and in the manner proposed by the commissioners, in which case a short act may this day be passed for the purpose.
