fame depreciation as soldiers of this state in the service of the United States; a memorial of Thomas Brooke Hodgkin, praying the general affembly to direct the payment of an account which has been passed by the auditor, for money expended in the public service; petitions of Henry Trader and George and James Fletcher, nonjurous in Somethet county, praying relief; and a petition of major John Lynch, fetting forth, that a certain Patrick Kennedy, early in the year 1777, went to the enemy, after making a will, deviling all his property to Edward and Mary Lynch, fon and daughter of the devifor's uncle; that the petitioner intermarried with the faid Mary Lynch, and afterwards, in September 1777, the faid Kennedy made and executed a deed of gift of all his property in Baltimore-town to the petitioner and his wife, which deed was by accident lost by the person to whom it was delivered; that the said Patrick Kennedy is now outlawed for high treason, and his property confilcated to the state; and praying the general assembly to secure to him and his wife the said property; severally endorsed; "By the senate, No. vember 28, 1781: Read and referred to the house of delegates.
