The bill to raise the supplies for the year seventeen hundred and eighty-two, was read the first time and ordered to lie on the table.

Mr. Jenifer, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act respecting the sale of the iron works late belonging to James Russell and company.

Mr. Mills brings in and delivers to Mr. Speaker the following report:

By the COMMITTEE appointed to enquire into and report the facts contained in the petition of Luke Marbury.

YOUR committee beg leave to inform the honourable house, that the said Luke Marbury, in the year 1777, commanded a battalion of militia of this state; that in August 1777 he was ordered into actual service, in which service he remained until the 4th of Octobr following, when he was taken prisoner until the 3d of September 1781, when he was exchanged.

Your committee observe, that by law, every officer of militia, while in actual service, is entitled to the same pay and rations as officers of equal rank in the continental service are entitled to; that the pay of a colonel amounted to seventy-five dollars per month, and an allowance of

two dollars per week for board while in confinement.

Your committee observe, that the said Luke Marbury received his pay and rations to the 4th of October 1777, so that his pay from that time to the 3d of September 1781, is three years and eleven months, which, at the rate of 75 dollars per month, amounts to £. 1321 17 6 specie, and his subsistance money, at two dollars per week, amounts to £. 153 0 0 specie.

Your committee observe, that the said Luke Marbury, during his confinement, at several times, received the sum of two hundred and five pounds eight shillings and three-pence specie,

and on the 19th of March 1781, he received 3000 continental dollars.

Your committee beg leave to refer the house to an account annexed to this report, by which

the net balance due to colonel Marbury, as your committee conceiving, will appear.

Your committee also beg leave to observe, that they are informed by colonel Marbury, that he was obliged while in confinement to borrow confiderable sums of money, which are yet unpaid, but which he holds himself bound, both by honour and gratitude, to pay in a short time; he also informed your committee, that the sum of £. 350 0 0 specie is absolutely necessary to enable him to settle with his creditors; colonel Marbury also informed your committee, that he is willing and defirous to receive either tobacco or flour for that sum at the current price, and . that if the honourable house do not supply him with that sum, or with the means of acquiring it, he must be thrown into very great difficulties.

All which is humbly submitted to the confideration of the honourable house.
