HE house met. Present the same members as on yesterday, except Mr. Maynadier and Mr. Tilden. The proceedings of yesterday were read.

The petition from Matthew Ridley was read, and referred to the next session.

Mr. Jeniser, from the committee, brings in and delivers to Mr. Speaker the following report: By the COMMITTEE appointed to inspect into and report the state and condition of the auditor-general's office, &c.

YOUR committee beg leave to report, that the auditor's books are posted up to the 24th day of November last. That the books containing the last emission of bills of credit, as also those containing the accounts of the former emissions of this state, and of the emissions of congress, are in as good a situation, as the nature of the case, and the constant alarms this state has been in during last summer, will admit of.

That the books containing the last emission, are more complete than the others; the others nearly in the same state as when last reported on. That from the nature of the auditor's bustnels, it is impossible for him, or this committee, to make out a general state of the expenditure of public money, so far as it hath come into the treasury, unless a certain time be fixed on for the auditor to balance his books, and this cannot be done during the fitting of the general affem-
