And be it enacted, That from all interest of money of tobacco which shall become due between the surfit day of January, seventeen hundred and eighty-two, and the first day of January, seventeen hundred and eighty-three, the debtor may deduct one sixth part of the said interest, any agreement to the contrary notwithstanding, and any contract hereaster made to the contrary shall be void in law; and if any creditor shall resuse to allow such deduction, he shall forseit treble the sum of money or quantity of tobacco by him so resused to be deducted, to the use of such debtor, and such debtor may recover the forseiture on warrant before a justice of the peace, if the sum does not exceed his jurisdiction, and if it does, by action at law, as for money or tobacco received to his use."
