That Peter Chaille, collector in Worcester county, has taken 10 horses, valued to £. 242 0 0, average value thereof £. 24 4 0. That Alexander Crawford, collector in Harford county, has taken 8 light horses, valued to £. 695 0 0, average value thereof £. 86 17 6; 13 draught horses, valued to £. 627 10 0, average value thereof, £. 48 5 4; total 21 horses, valued to £. 1322 10 0. That Henry Shryock, collector in Washington county, has taken 21 draught horses (geers included) valued to £. 606 10 0, average value thereof £. 28 12 10; 1 waggon, valued to £. 15 0 0; total 21 horses and 1 waggon, valued to £. 621 10 0. That Daniel Jenifer, collector of Charles county, has taken 19 draught horses, amounting to £. 682 10 0, of which 7, amounting to £. 227 10 0, were returned; and 17 light horses, amounting to £. 856 0 0, of which 7, amounting to £. 293 10 0, were returned, remains 10 light horses, valued to £. 562 10 0, average value thereof £. 56 5 0; and 12 draught horses, valued to £. 455 0 0, average value thereof £. 37 18 4; total 22 horses, valued to £. 1017 10 0. By the return of John Bullen, who was appointed by the governor and council to take care of and keep the said horses, there were 203 delivered to him, of which he delivered 183 to continental officers, by orders from the governor and council, and that 20 remain in his care. The number of horses, the returns of which we have not, amount to 56.
