Which was read the first and second time and concurred with, and leave given to bring in a bill pursuant thereto. ORDERED, That Mr. Morris, Mr. Waggaman, and Mr. Jenner, do prepare and bring in the said bill.

A bill, entitled, An act for establishing a new market and building a new market-house in Baltimore-town, and for the regulation of the said market, was read the first time and ordered to

lie on the table.

Mr. Chew and Mr. Bayly appeared in the house.

The bill to remedy the inconvenience arising to the inhabitants of Caecil county from the loss of their records, and other purposes therein mentioned, was read the second time and passed. Sent to the senate by Mr. Job and Mr. Brevard.

James McHenry, Esq; from the senate, delivers to Mr. Speaker the bill to punish persons contriving the escapes of prisoners of war, endorsed, "By the senate, May 22, 1782: Read the

first time and ordered to lie on the table.

Amendments proposed. In the 14th line of 1st page, after the word "war," insert, "know-

ing him to be fuch."

Strike out from the word "the," in the 3d line of the 2d page, to the word "who," in the 4th line inclusive, and insert, "fuch sheriff as the court before which such conviction is had shall direct, and such sheriff."

Strike out from the word "whipped" to the word "lashes" inclusive, in the 13th line, and

infert, " imprisoned not exceeding twelve months."

After the word "apprehend," in the 7th line from the bottom of 2d page, infert, "any prifoner of war having escaped the cultody of the officer who hath charge of him." After the word
"and," in same line, insert the words "such prisoner."

Afx - the word "county," in the 4th line from the bottom, infert, " fuch person, so appre-

hending and delivering such prisoner of war."

After the word "money," in the 3d line from the bottom, infert, "and one-eighth of a dollar per mile for travelling expences, also five ninetieths of a dollar for the subtlitude of each prisoner per day while confined, as directed by the resolution of congress of March 30, 1782."

According to order, the honourable the intendant appeared before the house, and after giving the house the best information he could respecting the amount of sales or British property, an account of the afrears of taxes due to this state, and also an account of the several emissions of money now in circulation, had leave to withdraw.

The house adjourns till 3 o'clock.

## POST MERIDIEM.

The amendments to the bill to punish persons contriving the escapes of prisoners of war, were read and agreed to, except that by which imprisonment is substituted in the place of corporal punishment; and thereupon the following message was prepared, and sent to the senate by Mr. Jeniser and Mr. Stone:

## BY THE HOUSE OF DELEGATES, MAY 27, 1782.

MAY IT PLEASE YOUR HONOURS,

WE have agreed to all your amendments fent down with the bill, entitled, An act to punish persons contriving the escapes of prisoners of war, except that by which imprisonment is substituted in the place of corporal punishment.

We wish your honours to recede from that amendment, as we believe that the shame and difgrace attending whipping, will have a tendency to prevent the commission of this crime, so injurious to the cause of America.
