MAY IT PLEASE YOUR HONOURS,

WE are really concerned, that from the want of a sufficient number of members to compose a senate, the governor and council could not be elected on Monday and Tuesday last, as directed by our constitution. The inconvenience and consequences arising from the want of an executive should ever be avoided, and no cause occurs to us, which could prevent the attendance of the legislature at the time appointed. We cannot but lament the neglect in our members, as well 28 yours, in not appearing on the first Monday in this month, as our form of government prescribes; not only duty but convenience dictate a contrary conduct, and we will readily join your honours in any measures which will compel the punctual attendance of the members of both

We propose to proceed to the election of the governor at one o'clock, and have appointed Mr. Brice T. B. Worthington, Mr. M'Mechen, and Mr. Forrest, to join the members nominated by your house to examine the ballot boxes; and William Paca, Esq; is put in nomination by

this house.

If agreeable to your honours, we will to-morrow noon elect the council to the governor. By order, W. HARWOOD, clk. Which was read the first and second time, agreed to, and sent to the senate by Mr. B. Wor-
