Your committee are of opinion, that the general assembly should propose to subjects of this state creditors of congress on loan-office certificates, to bring them in to the auditor, to be adjusted by him agreeable to the scale laid down by congress, and to take certificates from this state bearing an interest of 6 per cent. half thereof payable annually during the war in coin or continental bank notes, and after the war the whole interest to be paid annually in coin or bank notes.

On motion by Mr. Dashiell seconded by Mr. Forrest, ORDERED, That the report from the committee to whom were referred the requisitions of congress and the letters from the superintendant of finance to his Excellency the governor, &c. be taken into consideration at the meet-

ing of the house on Thursday next.

A petition from Mary Howlet, of Baltimore county, fetting forth, that her husband, about ten years ago, purchased about fifty acres of land from a certain Thomas Johnson, under the incumbrance of a right of dower; that he has left her some time; that before his leaving her he treated her very unkind, and has never been heard of fince; that the land is fince conficated, and praying relief in the premises aforesaid; was preferred and read, and referred to the committee on private petitions.

On motion by Mr. Cradock seconded by Mr. Forrest, Resolved, That the governor and the council be requested to issue their proclamation, appointing Thursday the twenty-eighth instant to be observed throughout this state as a day of public thanksgiving and prayer, agreeable

to the ordinance of congress of the eleventh of October.

ORDERED, That Mr. Chase request the reverend Mr. Gates to perform divine service on that day, and that he prepare a fermon for that purpose. The house adjourns till to-morrow morning 9 o'clock.
