

W E D N E S D A Y, November 27, 1782.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Brogden and Mr. Smyth appeared in the house. Mr. Cradock has leave of absence till Monday week next.

On motion by Mr. Dashiell seconded by Mr. Oneale, Leave given to bring in a bill allowing a longer time to compound on old certificates; and Mr. Dashiell, Mr. Oneale, Mr. Holland, Mr. Norris, and Mr. Dent, were appointed a committee by Mr. Speaker for that purpose.

Mr. Hopper has leave of absence until Tuesday next.

Mr. Dashiell, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act allowing a longer time to compound on old certificates; which was read the first time and ordered to lie on the table.

Mr. Forrest and Mr. M^cMechen have leave of absence till Saturday next. Mr. Taylor has leave of absence for eight days. Mr. Kirkman has leave of absence.

John Hanson, Esq; having served three years as a delegate to congress, and Mr. Wright and Mr. Hemley having served only one year, and Mr. Carroll two years, the question was put, That one of the said three delegates is ineligible, and that he ought to be balloted out agreeable to the 27th section of the form of government? The yeas and nays being called for by Mr. Chase seconded by Mr. Seney appeared as follow:
