THE committee to whom was referred the petition of Mr. Frank Leeke, of Prince-George's county, have taken the same under consideration, together with sundry papers relating thereto, and beg leave to report, That after considering the accounts of Mr. Leeke, and the nature of his situation as attorney for Mr. Philpot, are of opinion, that the real estate of said Philpot should be sold for the purpose of discharging his debts, and conceive Mr. Leeke the proper person to dispose of the same under certain directions, such as giving proper notice of the day of sale, not selling of the property under the assessment, and giving a reasonable credit, provision for which may be made in the bill.

Your committee inform the honourable house, that the petitioner became liable, previous to the present troubles, for the claim of Charles Hazledine against the said Philpot, for £. 2191 18 1, with interest thereon, and for which sum the heirs of the said H. zledine have obtained juigment. Mr. Leeke became answerable for the above debt, and a debt to a M. John Weems, from having the whole of Mr. Philpot's debts and real estate in his possession, by virtue of a power of attorney, and conceiving the essects sufficient to discharge the said Philpot's debts.

Your committee further observe, that provision was made at the last general assembly, in the case of John Briscoe and George Gray, who are circumstanced in the same manner that Mr.

Leeke is.

Your committee conceive, from the list of debts due Mr. Philpot, an account of which is handed in with this report, but unless the petitioner Mr. Leeke is authorised to dispose of the estate as mention don his petition, and apply the sales thereof to the payment of Mr. Philpot's debts, he must inevitably be ruined.
