The bill to empower John Cradock and Elizabeth Worthington, to convey in fee simple certain lands in Baltimore county to William Worthington, was read the second time and passed. Sent to the senate by Mr. Ridgely and Mr. S. Worthington.

The bill for laying out a road from Philip Shoal's mill, in Baltimore county, until it intersects the main road leading from Frederick-town to Baltimore-town, between Mansell's and Hood's tavern, in Anne-Arundel county, was read the second time and passed. Sent to the senate by Mr. M'Mechen and Mr. Fell.

Mr. Hopper, from the committee, brings in and delivers to Mr. Speaker a report on the petition of Edward Hargadine, of Queen-Anne's county; which was read the first and second time and concurred with, and leave given to bring in a bill pursuant thereto.

The bill empowering Martin Harry, administrator of John Waley, to sell and dispose of two lots of ground in the town of Shipton, in Washington county, was read the second time and passed. Sent to the senate by Mr. Chapline and M. Smyth.

The bill for the sale of the glebe land in Saint Mary Anne's parish, in Cæcil county, was read the second time and passed. Sent to the senate by Mr. Job and Mr. Brevard.

Mr. M'Mechen, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act concerning the jurisdiction of the county courts; which was read the first time and ordered to lie on the table.

And a bill, entitled, An act concerning estates tail; which was read the first and second time by especial order and passed. Sent to the senate by Mr. Stone and Mr. Ridgely.

On motion by Mr. Stone seconded by Mr. Norris, Leave given to bring in a bill, entitled, An act to repeal the taxes imposed and appropriated for the redemption of the two emissions of bills of credit in the years seventeen hundred and eighty and seventeen hundred and eighty-one; and Mr. Stone, Mr. Norris, Mr. S. Worthington, Mr. Ridgely, and Mr. Keene, were appointed a committee by Mr. Speaker to prepare and bring in the said bill.

Mr. Stone, from the committee, brings in and delivers to Mr. Speaker the said bill; which was read the first time and ordered to lie on the table.

John Henry, Esq; from the senate, delivers to Mr. Speaker the bill for the relief of John Gray (hatter), a languishing prisoner in Baltimore county gaol, endorsed; "By the senate, November 23, 1782: Read the first time and ordered to lie on the table.
