YOUR committee beg leave to report, That they have examined the proceedings and accounts of the commissioners for the preservation and sale of confiscated British property, and find that since the last session of assembly they have sold public property to the amount of \pounds . 82,970 15 2; for the redemption of officers and soldiers certificates to the amount of \pounds . 68,564; and for the defence of the bay and the recruiting service to the amount of \pounds . 10,860 17 6 specie; and for the use of the continental treasury to the amount of \pounds . 3,645 17 6.

It further appears, that on account of the specie sales, there have been paid into the hands of the commissioners the sum of f. 6,425 10 $2\frac{1}{2}$; and by their vouchers which they produced it appears, that they have paid into the treasury the sum of f. 3,58 11 8 specie; that they have paid to the commissioners for the desence of the bay the sum of f. 3,541 17 11; and also to the hands of general Smallwood for the recruiting service the sum of f. 2,292 13 f.

in the whole to £. 6,393 2 $11\frac{1}{2}$.

It also appears to us from the regulation of the commissioners, that sundry purchasers have refused to comply with the terms of sale, for different reasons, a list of whom we beg leave to annex to this report.
