of the legacies left to Elizabeth Dulany by her father and mother, not received by the faid Lloyd Dulany; also the money received by James Brice, as attorney in fact for the said Lloyd Dulany; but that the same be and remain in the hands of the said James Brice, for the use of the faid Elizabeth Dulany, subject to the further order of the general affembly.

Sent to the senate by Mr. Coursey and Mr. Sewell.

Mr. Kent, from the committee, brings in and delivers to Mr. Speaker the following report:

THE committee to whom were referred the representation of major James McHenry and captain Peregrine Fitzhugh, beg leave to report, That they have examined the allegations therein contained and find them true. That on the 12th of August 1780, congress recommended to the several states to make up the depreciation of pay to the officers and soldiers to them respectively belonging, and refolved, that they would take speedy measures for liquidating and paying what was due on that account to the officers and foldiers not belonging to the quota of any flate, which was the fituation of the above gentlemen. That congress never made up the depreciation to the officers and foldiers not belonging to the quota of any particular state, and finding the same impracticable, on the 31st of December 1781 resolved, that it be recommended to the several states to settle the depreciation of the pay of all the officers that are inhabitants of their respective it tes, and should retire from service under the preceding resolution (alluding to resolutions of the same day) in the same manner they settled with the officers of the line of their state, and charge the same to the United States.

Your committee further report, that this state, in pursuance to the last resolution of congress, has settled the depreciation of several officers, citizens of this state, who were not in the Mary-That the said major M'Henry and captain Fitzhugh were citizens of this state and officers in the army or the United States, though not of the quota of this state, and are within the last resolution of congress.

Your committee are therefore of opinion, that a resolution ought to pass, to direct the commissioner (who lettled the army's depreciation accounts) to settle the depreciation of the pay of the laid major M'Henry and captain Fitzhugh, and that the fame be charged to the United
