pears, there has become and still remains due from fundry persons, on the before mentioned

bonds, to the rst of June next, the sum of £.880 sterling for interest.

That your committee have also examined the several bonds taken by the commissioners for bills of credit emitted in virtue of an act of assembly passed November session 1773, and compared the same with a list thereof now remaining in the office, to the amount of £.6378 15 sterling; and that there has become and still remains due from sundry persons on said bonds, to the 1st of June 1783, the sum of £.1227 for interest.

That it appears to your committee, there is due from the supervisors of the public roads in Baltimore county, £. 378 1 8 sterling; from the supervisors of the road to the westward of Fort Cumberland, £. 31 14 9 sterling; from the supervisors of Baltimore county poor-house £. 2400 sterling; from the supervisors of the public roads in Frederick county, £. 1374 17 10 sterling; that there is also due on said books, from sundry sheriffs, £. 1880 9 3 gold currency, and from the collector of the land-tax in Queen-Anne's county for the year 1763, the sum of £. 73 17 2 gold currency.

That it appears to your committee, there is due to fundry claimants on the journal of accounts for 1766, the fum of f. 568 2 8; and the further fum of f. 424 7 2 currency due to fundry

claimants on journal 1773.

Your committee have also examined the several accounts and proceedings of Henry Dickinson, Esq; treasurer of the eastern shore, and find he hath received from the collectors of the several counties, the sum of £2035 1 9 in bills of credit of June 1780, and £.72 18 2 in bills of credit May 1781, on account of 7/6 fund tax; 36,048 h of tobacco, £.10,660 11 7 in specifics, £.221 19 6 in bills of credit June 1780, £.2513 17 9 in bills of credit May 1781, and £.11 11 8 specie, on account of specific taxes; and £.1321 17 9 on account of specie tax; also £.1391 13 10 in bills of credit May 1781, on account of 3/9 fund tax; for sines and forfeitures, £.22 17 6 in bills of credit June 1780, and £.33 18 6 in bills of credit May 1781; for ordinary and marriage licences, £.187 17 6 in bills of credit June 1780, and £.207 5 6 in bills of credit May 1781; from naval officers, £.28 7 5 in bills of credit June 1780; from lieutenants of the several counties, £.5 5 June emission 1780, and £.744 13 3 May emission 1781; and for caution on land, £.57 9-9 specie.

Your committee also find, that the said treasurer hath paid away, to the 15th of May 1783

inclusive, L. 1390 19 2 specie, L. 4964 7 May emission 1781, L. 1396 0 9 June emission 1780, and accounted for and paid away specific articles to amount of L. 19,695 13 4, and 36,048 spot fobacco, for all which payments have been produced to your committee the necessary vouchers

aud receipts.
