The bill to establish a market-house in Elizabeth-town in Washington county, was read the

Mr. Ridgely, from the committee, brings in and delivers to Mr. Speaker the following repport THE committee appointed to enquire into and report on the memorial of captain William Stone, of Baltimore county, having examined the allegations submitted to their confi eration, beg leave to report, That captain William Stone being owner of a certain brigantine called the Friendship, whereof John Martin was commander, did charter the said brigantine to a committee of the convention on the 31st day of December, in the year 1775, to perform a voyage to the West-Indies on freight, as by the charter party will fully appear; that the faid briganine proceeded on her voyage, and after having performes the same, and dis harged her cargo at the island of Martinico, proceeded to Saint Eustatia under the orders and direction of captain William Stone; that while the said vessel lay at the island of Saint Eust tia, John Martin, captain of said brigantine, disposed of her, and gave a bill of sale therefor to Richard Harrison, at that time agent for this state, for the sum of nine hundred pounds current money, without any authority vested in him by the owner to dispose of said brigantine; that it appears by sundry depositions, that captain John Martin was induced to make the transfer of faid vessel, from an assurance that, in case the sale was disapproved of by captain Stone, that she was to be returned to him on her arrival at Baltimore, together with an allowance of ten per cent. from freights. That it does not appear to your committee, that any part of the consideration money was ever paid to captain Stone, or that the faid Richard Harrison paid any money in the West-Indies on occount of the said petitioner. It further appears, that the said brigantine hath since (under colou of the said sale) been in the service of the state, and performed several profitable voyages, whereby the acquired considerable freights. Your committee further beg leave to report, that captain William Stone instituted a writ of replevin for recovery of the said vessel, and that the sheriff of Baltimore county executed the faid process, and delivered the vessel to captain Stone; that immediately afterwards, captain John Martin, who was in the service of the state, rescued the said vessel with force from the custody of the petitioner, fince which time the said petitioner hath made several applications to the legislative powers of this state for redress, but the affair hath been fr m time to time delayed in the opinion of your committee, to the great injury of the lait captain William Stone. It also appears to your committee, that the said brigantine was new, substantially built, well found and fitted, and was valued, immediately after serving the said writ of replevin, by four persons of skill and judgment, to the sum of eighteen hundred pounds Maryland currency. Your committee are therefore of opinion, that the governor and council be authorised and empowered to settle and adjust, by arbitration, the dispute aforesaid, sublisting between this state and the aforesaid captain William Stone, relative to the brigantine asociaid, or any other matter or thing relating to the same. All which is submitted to the honourable hou e.
