Mr. Carroll brings in and delivers to Mr. Speaker the following report from the auditor:

To the honourable the GENERAL ASSEMBLY of MARYLAND.

THE deranged state of the public accounts in the auditor's office, renders it absolutely neceffary that the following report be made to the honourable house of assembly, by the person now acting as auditor-general of Maryland.—He finds, upon looking over the books, that the accounts passed in that office since September, 1782, are not posted up in the general ac-This defect, he supposes, may have been occasioned by the encrease of business in the office, such as settling the officers and soldiers accounts for depreciation of pay, which was formerly done by commissioners, and by the liquidation of loan-office certificates. The first of these duties now takes up the whole of the auditor's time, and is indeed faster pressed upon him than it can be executed to the fatisfaction of those who apply. The other business sufficiently takes up the labour and attention of the deputy, so that the urgent business of preparing the accounts for the commissioner for settling the continental claims of the state, and the commissioner for settling with the officers and soldiers of the army, cannot by them be attended to. Both the commissioners are waiting for the necessary papers, which cannot by this office be prepared, without the auditor is allowed the assistance of some clerks for that purpose. He has extracted from the instructions of the commissioners the following parts, upon which he has ventured to make a few observations, which are submitted to the honourable house, and he doubts not they will take such order therein as the nature and urgency of the cases require. Extract from the instructions of Mr. Nourse, commissioner for settling the continental account with the state of Maryland.

Ift. YOU will receive herewith a fet of books, in which are to be recorded, in a fair and regular manner, all accounts and settlements by you made. These books are ruled with double fets of columns—in the first of which will be inserted the nominal sum in dollars and ninetieth parts of a dollar-and in the fecond, the specie value of each sum, according to the dates, in
