HE house met. Present the same members as on yesterday, except Mr. Harwood, Mr. Plowden, and Mr. Ogle. The proceedings of yesterday were read. Mr. Hindman appeared in the house. Mr. Nehemiah Holland, a delegate returned for Worcester county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, took his feat in the house.

A petition from John Galloway, of Baltimore county, fetting forth, that he did not take the oath of fidelity to the state according to law, and praying to be invested with the same privileges as other citizens of this state; was preferred and read, and referred to Mr. McMechen,

Mr. Ridgely, and Mr. Carroll, to confider and report thereon.

A letter of refignation from Mr. Thomas Firman Ecclefton, a delegate returned for Dorchefter county, was read and accepted, and thereupon ORDERED, That Mr. Speaker iffue his warrant to the sheriff of Dorchester county, for the electing a delegate in the room of Mr. Ec-Which issued accordingly, returnable on or before the first day of January next.

Mr. Hammond, from the committee, delivers to Mr. Speaker An additional supplement to the act, entitled, An act for the liquidation and payment of debts against persons convicted of

treason; which was read the first time and ordered to lie on the table.

A petition from sundry inhabitants of Washington county, praying an act may pass, to divide faid county, for the ease and convenience of the people of said county, was preferred and read, and referred to Mr. M'Mechen, Mr. Swingle, Mr. Jacob, Mr. Quynn, and Mr. Oneale, to confider and report thereon.

Mr. Ridgely, from the committee, brings in and delivers to Mr. Speaker the following re-

port:

THE committee to whom was referred the petition of John Galloway, beg leave to report, That they have examined the same, and fundry certificates recommending said Galloway, and are of opinion that he ought to be relieved agreeable to the prayer of said petition. All which is fubmitted to the honourable house.

By order, Which was read the first and second time, and concurred with, and leave given to bring in a A. GOLDER, clk. bill pursuant thereto; and Mr. McMechen, Mr. Quynn, Mr. Wootton, Mr. Hammond, and Mr. Ridgely, were appointed a committee for that purpose.

Mr. M'Mechen, from the committee, brings in and delivers to Mr. Speaker the following report:

THE committee to whom was referred the petition of captain Carcaud, beg leave to report, That they have examined the same, and from a representation of the said captain it appears, he left this state and went to England in seventeen hundred and seventy-five; that he remained in the British dominions until June, 1782, when he went to Ostend, and became an Imperial subject; that he did not return to this state till the ninth of June, 1783; that the said Carcaud, during the war with Britain, did not go into the British service, either by land or water, but returned to his native country the Jersey, and remained in a private capacity almost during the war; that upon his arrival in this state, he took the several oaths required by the constitution and form of government. Your committee had no other papers or proofs thereof, except the representation of said Carcaud.

Your committee are of opinion, that the said Carcaud does not come within the exception of the act for the seizure and confiscation of British property, not having returned before the first

of March, 1782.

Which was read.

Your committee beg leave further to report, that the said Carcaud became a subject of a neutral state, and is warmly recommended by a number of worthy citizens of this state, and in the opinion of your committee, is a poor unfortunate man, in a diffressed situation, with a wife and a number of helpless children.

All which is submitted to the consideration of the honourable house.
