THE committee to whom was referred the petition of Duncan Campbell and James Burney, prisoners now in Talbot county gaol, beg leave to report, that they have examined the vouchers and papers relative thereto, and find they did petition the justices of said county for the benefit of an insolvent act now existing. That the justices did not apprehend the general insolvent act passed in the year 1774 was then in force, and refused them the benefit of the aforesaid ad, We also beg leave to observe, that the prisoners advertised in May last their intention to petition this affembly for relief. Therefore your committee are of opinion, that they ought to receive the countenance of the legislature, and be relieved accordingly. All which is submitted to the honourable house.
