

VOTES AND PROCEEDINGS, NOVEMBER 1784. 85

The report on the petition of Sarah Parran of Calvert county, was read the second time, concurred with, and leave given to bring in a bill pursuant thereto.

Mr. De Butts, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act relating to interest in certain cases, and other purposes; which was read the first time and ordered to lie on the table.

The bill to raise the supplies for the year seventeen hundred and eighty-five, was sent to the senate by Mr. De Butts.

On the second reading the estimate for the civil establishment for the year seventeen hundred and eighty-five, the question was put, That a salary of eight hundred pounds current money be allowed the governor for the present year? The yeas and nays being called for by Mr. Taney appeared as follow:
