Amendment proposed. Strike out from the word "and" in the 10th line, and insert, "Provided that the bond given by the faid Thomas Contee fhall be liable to be fued for any breach of the trust reposed in him by the said acts, during the continuance of the same, by the said William and Robert Molleson, or either of them, or by any creditor of them or either of them."

WHEREAS Robert Reynolds, late sergeant at arms, hath presented a memorial, representing, that in April session seventeen hundred and eighty-three, summons were directed to be issued by the honourable house of delegates, for fundry persons who resided in Harsord county; that as sergeant at arms he was under the necessity of hiring a man and horse for five days, at ten shillings per day, which, with the expences of the messenger and his horse, amounts to five pounds feven shillings and fix pence; that the fees for serving the summons amount to two prunds eight shillings, and that the persons at whose instance and request the said summons were issued, were discharged by the house before the tees due to the officers were paid, by reason of which he has never received any part of the aforesaid sums; and praying, that as he acted in his official capacity, and in obedience to the orders of the house, in serving the summons aforesaid, that a refolve might pass, enabling the auditor to adjust his account for what may appear due to him for the services aforesaid: Therefore, Resolved, That the auditor-general be, and he is hereby directed, to fettle the accounts of the feid Robert Reynolds for the expences of serving the summons aforefaid, and that the intendant give him an order on the treasurer of the wettern shore for the amount thereof.
