RESOLVED, That a committee be appointed to revise the act to impose duties on certain enumerated articles imported into and exported out of this state, and to report whether any or what alterations or amendments are necessary thereto. Mr. B. Worthington, Mr. Waggaman, Mr. Faw, Mr. Chase, Mr. Steret, Mr. Joshua Seney, and Mr. Ramsey, were appointed a committee for that purpose.

A petition from fundry inhabitants of Baltimore town, praying an all may pass to establish a health office at Baltimore-town; was preferred and read. ORDERED, That Mr. Joseph Dashiell,

Mr. Steret, and Mr. Wootton, be a committee to confider and report thereon.
