BY THE HOUSE OF DELEGATES, MARCH 8, 1786.

MAY IT PLEASE YOUR HONOURS,

WE propose to ballot at 2 o'clock this day for commissioners, to meet commissioners from Virginia, Pennsylvania, Delaware, and the other states in the union, to confer on such subjects as may concern the commercial interests of the said states, and to consider whether an uniform system in the commercial regulations of the states is necessary and practicable. We think seven commissioners ought to be appointed, and have nominated Mr. F. Bowie and Mr. Digges to join such members of your house as you may appoint to examine the ballot boxes. The following gentlemen are put in nomination as commissioners by this house, to wit, Thomas Johnson, Samuel Chafe, William Paca, Charles Carroll, of Carrollton, Daniel of Saint Thomas Jeniter, John Hall, Thomas Stone, Robert Hanson Harrison, William Hemsley, Otho H. Williams, and Tench Tilghman, Esquires, to be balloted for.
