W E D N E S D A Y , April 18, 1787.

On motion, ORDERED, That Mr. Quynn and Mr. Jenings wait on his excellency the governor, and inform him that this house is met and are ready to proceed on public business, and to receive any thing he may think proper to lay before them. They return and acquaint Mr. Speaker they delivered the message.

The house appointed Mr. Archibald Golder, Mr. William Pinkney and Mr. Thomas Purdy, committee clerks. ORDERED, That they be qualified.

ORDERED, That Mr. Paca, Mr. Johnson, Mr. M'Mechen, Mr. Quynn and Mr. John Seney, be a committee to examine and inspect the returns of Elections, and report whether they have been
