A petition from William Whiteley and Henry Downes, of Caroline county, praying a law may pass to revive the proceedings of said county, was preferred, read, and referred to the committee appointed to prepare a bill to determine at what place the public buildings of Caroline county shall be erected.

The bill for the relief of Jane Nicols, was read the second time and passed. Sent to the senate

Mr. M'Mechen, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act for incorporating the German reformed congregation in Baltimore-town; which was read the first and second time by especial order and passed. Sent to the senate by Mr. M'Mechen.

Richard Ridgely, Esquire, from the senate, delivers to Mr. Speaker a memorial from William Stone, Smith and Morton, and others, of Baltimore county, fetting forth, that they have experienced great injustice from the act imposing a duty on rum, other liquors and sugars, according to the invoice or quantity specified at the port where the same is shipped; that frequently in the course of voyages great waste arises from leakage and other causes, so that the quantity specified in the cargoes thipped are greatly leffened; and praying that a law may pass, making provision that no duty shall be demanded for a greater quantity of spirituous liquors and sugars imported than shall be afcertained by the sworn gauger and weigh-masters in Baltimore-town: A petition from Robert Stewart, setting forth, that he purchased of the commissioners for the preservation of conficuted British property, 150 acres of land, at the rate of £. 6 3 0 per acre, payable in continental state money; that on the 20th day of August, -1782, he procured the sum of £. 983 2 4 of the aforefaid money, and intrusted a certain Philip Thomas with the same, who promised to pay it into the treasury, and take up his bonds granted for said lands; that the said Thomas, instead of applying the fame to his use, applied it to purposes of his own; and as the said Thomas has since died a bankrupt, he is not only rendered incapable of complying with his contract, but will be undoubtedly ruined, unless relieved; and praying to be released from the said contract, or that such other relief may be granted to him as shall appear reasonable: And a petition from William Stone, respecting the brigantine Friendship, chartered to the council of safety in the year 1775; severally endersed; "By the senate, April 27, 1787: Read and referred to the consideration of the house of delegates.

A petition from Thomas Gift, junior, of Baltimore county, respecting certain confiscated British property purchased by him in continental state money, was preferred, read, and referred to the committee appointed on the petition of Benjamin Nicholson, to consider and report thereon.
