On motion, Leave given to bring in a bill respecting the continuance of civil suits in the general and county courts. ORDERED, That Mr. Chafe, Mr. T. Johnson, Mr. M'Mechen and Mr. Paca, be a committee to prepare and bring in the same.

A petition from the presbyterian congregation of Bladensburg, praying a law may pass authorising the said congregation to hold a legacy bequeathed to the said congregation by a certain John Brady, was preferred and read.

Mr. Chafe, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act respecting the continuance of civil suits in the general and county courts; which was read the first time and ordered to lie on the table.

RESOLVED, That the treasurer of the western shore be, and he is hereby directed to retain in his hands the monies (except the two shillings and six-penny tax, and what is appropriated to congress) which now are, or the first that may come into the treasury, and apply the same to the payment of the allowances of the members, clerks and officers, of the general assembly, jurymen and witnesses.

A petition from Belain Posey, of Charles county, praying an act may pass to confirm his title to a tract of land lying in said county, called Grub's Venture, or Crane's Low-Grounds, which he purchased from a certain George Crane, and to release him from any composition for the said land, was preferred, read, and referred to Mr. Dent, Mr. M'Pherson and Mr. Joshua Seney, to consider and report thereon.
