The committee are of opinion, that under the confederation, the debts suffly due to citizen of the United States from persons of this state, whose estates have been forfeited for treason; sught to be paid when the estates so forseited are sufficient for the payment thereof, and that the chief of Adam Hubley, representative of the aforesaid Robert Field, and also the claim of the aforesaid Thomas Riche, when passed by the auditor-general, ought to be discounted out of the bond given as aforesaid by the said William Smith and Joseph Nicholson.
