The house having qualified agreeably to the constitution and form of government, proceeded to the choice of a governor, and the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time reported, that it appeared that the honourable Thomas Johnson, Esquire, had a majority of votes. Whereupon,

RESOLVED, That the honourable Thomas Johnson, Esquire, be and he is hereby declared go-

vernor of Maryland.
