inspected force time in the year 1785 and not yet called for, to contribute, in some degree, to his relief from that heavy expence which he has been at in consequence of his suretyship; was preserred, read, and referred to Mr. Chapman, Mr. Matthews and Mr. Faw, to consider and report thereon.

A petition from George Hanson, late sheriff of Kent county, praying an act may pass, empowering him to collect officers sees due to him in the same speedy way he might or could have done while theriff of faid county, was preferred, read, and referred to the committee on the petition of James O'Bryon.

The order of the day respecting the petitions of Jonathan Hagar and Daniel Heester, is postponed

till Wednesday next.

A petition from John Parker, of Prince-George's county, fetting forth, that a flave of his was condemned in Prince-George's county court to be hanged, for committing a rape on the body of a white woman; that his excellency governor Smallwood reprieved him, on condition that he should be transported to the West-Indies; that before an opportunity offered to transport said slave he ran away, and was taken and committed to the sheriff of Frederick county, who advertised him, and afterwards sold him for his prison sees, and praying a compensation for said slave; was preferred, read, and referred to the committee of claims to confider and report thereon.
