A petition from Francis Lowndes, fetting forth, that he is proprietor of the new warehouse at George-town; that there has been no provision made, as has been usual, for setting up prizes, scales and weights, necessary for the inspection of tobacco, and that the whole expence has fallen on him, and praying relief in the premises; was preferred, read, and referred to Mr. O'Neale, Mr. Dorsey and Mr. Cramphin, to consider and report thereon.
