Amendment proposed. At the end of the bill aid, "provided the said trustees enter into bond, before the presiding justice of Charles county, with security if required, to insure the application of the money arising from the sale to the purpose intended by the said act, and to account for any surplus that may remain after discharging the balance therein mentioned."
