the constitutional privileges of this house, notwithstanding the expediency of the bill, and the session being so near an end, had not the most essential been previously agreed to by us in the form of resolutions; but as even this concession of our power may hereafter be brought into precedent in cases of a more important nature, we hereby declare, that the permitting our resolutions to be ingrasted into the bill as amendments, shall not extend to the prejudice of the privilege of this house, and shall not be drawn into example.
