towmack, until the first day of January, seventeen hundred and ninety-four.

2d. That none of the shares, not already fold or subscribed for, be hereafter taken up, but on the purchaser or subscriber first paying the full amount of the previous calls for money made by the president and directors of faid company, and interest thereon from the time such calls ought to have been complied with.

3d. That all delinquent subscribers be obliged to pay interest from the time the money called for ought to have been paid, with the actual expense of ferving notice on such delinquents, to be reco-

vered in like manner, and with the principal.

4th. That foreigners be enabled and permitted to purchase, or subscribe for and hold, shares in the 5th. That the place of collection of tolls be at or near Hook's Falls, instead of at or near Payne's Patowmack company.

6th. That one third part of the tolls granted by the act of incorporation, which were demandable and to be received at the Great Falls, on the navigation being completed, be now demandable and received at the faid Great Falls, and also on all goods, commodities and produce, landed at or near Watts's Branch.

7th. That the faid prefident and directors of the Patowmack company be empowered to apply any part of the capital subscribed, and also the tolls as they may arise, to the opening, improving and ex-

tending, the navigation on the branches of the river Patowmack, above Seneca.
