taxes aforesaid, by which he will sustain a certain loss of £. 1282 12 7, with interest, the petitioner ought to be indulged by the legislature with a credit of ten years, on paying the interest annually.

Your committee therefore recommend it as the immediate interest of the state, to take back the property, and release the said securities, being convinced it is all they will ever obtain from them; in which case they are willing to relinquish the payments that have been made, to the amount of £.2217 19 2.
