The bill to establish a third inspection of tobacco in George-town, in Montgomery county, was

read the second time, passed, and sent to the senate by Mr. Burgess.

Mr. Tilghman, from the committee, brings in and delivers to Mr. Speaker the following report: THE committee to whom was referred the confideration of what measures may be necessary to be taken by this state in consequence of the assumption of the state debts by congress, report, that upon a serious consideration of the subject reserred to them, they are of opinion, that the interest of the flate is effentially concerned in its creditors subscribing to the loan proposed by congress in the act making provision for the debt of the United States. It appears to your committee, that the terms of the assumption by the United States will not do complete justice to the public creditors. them therefore to accept those terms, the state is bound, in justice, to offer them an equitable compensation. Impressed with these principles, your committee beg leave to submit to the house the following propolitions:

11t. That it be proposed to the public creditors to subscribe to the loan proposed by congress, and

that this state will make them a full compensation.

2d. That all that part of the subscribed debt, which, by the terms of the assumption, carries an immediate interest of six per cent. shall be considered, between the state and its creditors, as completely satisfied; that the part of the said debt which bears an interest of six per cent. after the year 1800, shall be considered as a payment of eight shillings and sour-pence in the pound, and the state will make up the deficiency; that the part of the faid debt which bears an immediate interest of three per cent. shall be considered as a payment of ten shillings in the pound, and the state will make up the deficiency; fo that, upon these principles, the state shall pay to its creditors at the rate of twentynine pounds twelve shillings and seven-pence for every hundred pounds subscribed, which shall be taken as a full fatisfaction.

3d. That the payment of twenty-nine pounds twelve shillings and seven-pence per hundred above mentioned, shall be made by the state to the public creditors in certificates issued under the said act making provision for the debt of the United States, bearing an immediate interest of fix per cent. and that, in order to establish a fund for the said payment, a trustee shall be appointed to subscribe the continental paper now in the treasury to the loan proposed by congress, and to receive certificates for

Your committee are further of opinion, that as this system will, in all probability, take out of circulation great part of the state certificates in which the public creditors have a right to discharge their debts, juffice requires that fuch measures should be taken as shall place them in as good a situation as To effect this purpole, your committee submit to the house the following prothey were before.

polids: 1st. That the public debtors included in the ast passed at November session, 1789, entitled, An act respecting the debtors and creditors of this state under the act to establish funds to secure the payment of the state debt within fix years, and for the punctual payment of the annual interest thereon, shall be allowed to make payment as follows: All arrears of interest up to the first day of December, 1790, in certificates issued under the act of congress making provision for the debt of the United States, bearing an immediate interest of fix per cent. or in state certificates two thirds of the principal in certificates of the same kind; one third of the principal in certificates issued under the faid act of congress, bearing an interest of fix per cent. after the year 1800. All interest arising after the first of December, 1792, shall be paid in specie.

2d. Those debtors who have installed, shall have an indulgence for the first payment till the first

day of August next.

3d. Those debtors who have not installed, shall have an indulgence until the first day of August next, and may be allowed to install on the principles established by the instalment law passed at November session, 1789.

4th. If the debtors, who have not yet installed, shall install before 13 August next; the attorneygeneral shall discontinue any suits or executions against them, on their first paying all legal costs and

charges.
