RESOLVED, That the governor and council be and they are hereby directed to ascertain the amount of the interest due on the loan of two hundred and seventy thousand florins, negotiated for this state by the late Mr. Ridley, computed to the first day of January, seventeen hundred and nine-ty-one, reckoning the same on the principles of simple interest, and estimating the money paid by the thate at the rate of three shillings current money for each florin; and that the treasurer of the western shore pay the said order out of the money now in the treasury lately under appropriation for the payment of the faid interest.
