THE committee to whom was referred the petition of George Wallace, beg leave to report, that on examining the premises, they find that a certain Leonard Strous bought of the commissioners for the sale of confiscated property, a certain lot in Elkton, in Cæcil county, known on the plot by the number 26, containing one acre of land, for the sum of £.45, which sum said Strous neglected to bond for or make payment, on which a sieri facias did issue against the said lot, by order of the deputy state's attorney, on the 30th day of October, 1786, and on the return of faid writ, a venditioni exponas was iffued on the 30th day of April, 1787, and the sheriff of faid county, by virtue of said writ, did expose said lot to public sale, when the petitioner, George Wallace, became the purchaser, and did, on the eighth day of August, 1787, by direction of the deputy state's attorney, pay unto the said sheriff the full amount of the purchase money, and take his deed of conveyance for said lot; which conveyance, the said petitioner apprehends, does not convey a good title in said lot.

Your committee are of opinion that it is but just and reasonable, as the said sale was made by the officers of the state, that it should be confirmed, on the said Wallace's paying the sum of £. 17 15 current money, being the difference between the sale made by the said commissioners and the sale made by the theriff; and your committee recommend that a resolution should pass directing that a

patent should issue, on such payment being made for said lot, to the petitioner.
