The committee are further of opinion, that one other road should be opened at the expense of the petitioners for said road, branching from the aforesaid road near Leggett's ford down the east side of Jones's Falls by Hanson's upper mill, from thence to the north corner of Tagart's dam until it

intersects the old road leading to Baltimore-town near said dam. By order,
