W E D N E S D A Y, November 30, 1791.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. William Whitely, a delegate returned for Caroline county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, and taking the oath to support the constitution of the United States, took his seat in the house.

The bill for the benefit of Susanna Howser, formerly widow of Casper Fritchie, and her children, was sent to the senate by the clerk.

Mr. T. Gantt, from the committee, brings in and delivers to Mr. Speaker the following report:

THE committee to whom was referred the petition of Thomas Contee, report, that they have examined the facts set forth in the said petition, and find them true, and are of opinion that a law ought to pass, vesting a power in the justices of the said county to have the warehouse valued by sworn appraisers, and that they levy on the inhabitants of the said county a sum sufficient to pay your petitioner such valuation. All which is submitted to the honourable house.
