The committee therefore are of opinion, that the justices of Prince-George's county ought to be empowered to levy a sum of money sufficient for the support and maintenance of the said Mary Brown and Eleanor Love. RESOLVED, That it be recommended to the delegates representing this state in the congress of the United States, to take such measures as may appear to them advisable in order to procure a reasonable extension of the time for this state to complete her quota of the debt proposed to be assumed by the United States, and also to obtain a provision that all debts, or evidences of debts, contracted or issued by this flate for expences incurred on account of the late war, be admitted to be subscribed at whateyer period the same be adjusted, previously to the expiration of the time to be limited for subscription; and provided, that such extension of time and provision for adjustment shall be confined to such flates only as have not yet subscribed the proportion of the assumed debt originally assigned them.

RESOLVED, That the treasurer of the western shore be and he is hereby directed to preserve any certificates, or evidences of debts, which, in the hands of individuals, would be subscribable as part of this state's quota of the assumed debt, now remaining in the treasury, or that may be at any time hereafter paid therein on account of any public demand whatever, and to lodge the same in the hands of the trustee of the state, to be by him subscribed for and on account of the state, if congress shall, at any time hereafter, extend the time for completing this state's quota of the assumed debt.

Whereas it appears by the report of the trustee that many holders of certificates, received by them in lieu of continental certificates under the act of November session, 1782, have subscribed the same to the loan of the United States, and have received stock therefor of the following descriptions and amount: Of fix per cents. 45,126 dollars and 17 ths, three per cents. 33,844 dollars and 62 ths, deferred, 22,563 dollars and 100 ths: And whereas the faid truftee has subscribed the original condeferred, 22,563 dollars and 100 ths: And whereas the faid truftee has subscribed the original condeferred, tinental certificates that were received in lieu of those issued under the said act of 1782: And whereas the act of congress requires that certificates issued by any state in lieu of continental certificates, shall be exchanged or redeemed before interest can be paid on either description; therefore, RESOLVED, That the truftee be and he is hereby directed to fet apart and decline drawing interest on, or if neceffary to transfer to the United States, so much of the different kinds of stock belonging to this flate as will amount to the sum so subscribed by persons who possessed the certificates issued under the act of November session, 1782; and resolved, that the said trustee be directed, in case the time for subscribing to the assumption loan should be extended by congress, to transfer, in like manner, to the United States, for any further sum of such certificates as may hereafter be subscribed.
